President Fleischhauer called the meeting to order in the High School/Middle School Library at 7:35 pm.

4.0 Reports and Discussion

4.1 2015-16 Budget Development Update

Superintendent Phelan reported that there has been no new budget-related information since the budget workshop on Saturday. He reminded the Board that the District has two more public meetings before the adoption of a budget on April 21, 2014.

4.2 Principals Reports

Chancellor Elementary School

Mr. King reported that the OLWEUS bullying/school climate survey was administered to all students in grades 3-5 this week. Upon receipt of the results, the BLPT hopes to discuss and set short and long term goals based on the results.

PE teachers have been logging the mileage of students during their biweekly runs for the first 5 minutes of gym class each day, and currently, the students have logged enough miles to reach Columbus, Ohio, with a total of 750 miles logged and a total of 75,330 calories burned as a school.

Mr. King wished to thank Alison Vaccarino, David Woulfin and the Rhinebeck Science Foundation for the STEM Fair event. CLS had 25 students participate with examples of projects like a potato battery, crystal growth, and a simulated fog tornado in a controlled environment. Also, a few districts have expressed their interest in visiting our STEM lab in May.

A concert by the High School Band, Men's Chorus, and Women's Chorus will be performed for elementary school students on Wednesday, March 25.

Bulkeley Middle School

Mr. Kemnitzer reported that the 6th Annual Top Chef competition was a great success, with 37 submissions entered by 45 students. Entries were submitted in three categories: main dish, side dish, or dessert. Mr. Kemnitzer wished to thank the judges from local restaurants, CIA grads, teachers, and administrators for their participation. One of the judges, Larry Anthony, District Food Service Director, hopes to incorporate some of the winning recipes on the lunch menu.

Despite difficulties in soliciting presenters, the BLPT and several teachers were able to pull off a very successful Artists-in-Action Day. Kathleen White served as keynote speaker with a very inspirational speech about why art is important. Following her address, students participated in small group presentations.

In 7th grade ELA classes, students have been working on their literature unit titled "The Outsiders". Students select from 6 titles and examine the common themes of

bullying and social isolation through student facilitated discussion in literature circles.

In 8th grade classes, thanks to the collaboration of Kristin Koegel and Brian McDonald, students have just completed a project from the GTT Energy and the Environment module, during which they used their research and knowledge of aerodynamics to design and fabricate their own wind turbine blades.

The BMS Anthropology Club continues to work with local documentarian, Seth Kramer, and others to create a documentary video comparing how children their age spent their free time years ago versus today. Upon completion, they intend to identify potential community needs and make a presentation to the Town Board.

Preparations are under way as State testing is set to begin shortly after we return from break. ELA Assessments will take place on April 15-17 and the Math Assessments on April 22-24.

Rhinebeck High School

Dr. Davenport commended the student council for a great pep rally. The high school, in cooperation with CAPE, will host a Teen Driving presentation, attendance at which is required in order to obtain a parking permit in the student parking lot.

In BLPT news, letters have been sent to families regarding the proposed discontinued use of rank on student transcripts starting next year. Most families are in favor of the change. Guidance is currently working on the procedures.

The high school will host a welcome back BBQ for last year's graduates in hopes to receive feedback on their experience after high school.

In the English department, Sarah Heady, poet and alumni, spoke to students about writing and her career. The department also is working on the development of a writing lab in order to provide extra help for students.

In the Math department, students are using internet resources in class and will pilot a partial "flipped" classroom next year. Students will be using Kagan structures which are designed to support collaborative work between students and gives opportunities for teachers to engage students.

In the Science department, students are focusing on freezing point depression and answering a series of questions based on colligative properties. There will also be a challenge on how cold students can make salt water before it freezes.

In PE news, students are studying Tchoukball, a sport that doesn't embody the aggressiveness of current team sports. Tchoukball removes the confrontational aspect of most team sports by not allowing teams to interfere with each other's game, thus ensuring that each team concentrates on its own game.

The New York State Education Department is requiring the administration of field tests in Common Core Algebra, Physics, and Global History and Geography.

The program of studies has been finalized and will be posted on the website, as well as shared digitally.

The Board had a short discussion on how well prepared our students are for the next reiteration of the SATs. The Board also discussed the state's focus on testing and taking time away from instruction by requiring schools to administer the PSATs during the school day and by requiring schools to administer field tests.

4.3 2015-16 BOCES Budget Overview*

Superintendent Phelan reminded the Board of the upcoming BOCES administrative vote on April 21. As requested by the Board at their last meeting, an information packet was distributed to board members regarding the BOCES proposed budget. Mr. Burnell went over the packet with the Board.

4.4 Board Committee Reports (Personnel, Policy, School Start Time, Finance)* Personnel Committee

Mrs. Lyons reported that the Personnel Committee is covering topics covered under staff salaries best discussed in detail during executive session.

Policy Committee

Mrs. Lyons reported that the Policy Committee reviewed and approved changes to the homework policy which is under review with administrators.

The committee discussed the exemptions for immunizations. The only allowable exemptions are medical and/or a sincere religious belief. The committee would like to explore a possible policy that would require supporting documentation and to assign one person in the district to make these determinations. The Board agreed that due to the possible impact an outbreak could have on the population, it seems prudent to investigate this further with administration and legal.

School Start Time Ad-Hoc Committee

Mrs. Lyons reported that the School Start Time Ad-Hoc Committee reviewed additional research. Currently, the committee has been exploring the feasibility of four (4) options:

- “Flip/flop” elementary and secondary bus runs
- “Single-trip” bus runs which include all students
- Maintain a bus configuration similar to our current one, but with secondary students starting a little later
- Maintain the current bus schedules

Mr. Burnell continues to work with the bus company to determine changes in costs and the possibility of shifting the secondary run 30 minutes later but keeping CLS

at roughly the same start time. The committee outlined a timeline that would have a recommendation on the agenda for a vote by the end of June.

Several members of the Board felt the timeline may be too aggressive, expressing concern that the District give many opportunities through various formats for the community to weigh in on this issue.

Finance Committee

Mrs. Lyons reported that the Finance Committee discussed the fourth draft of the budget, which is approximately under \$300,000 short of the tax levy limit. The Committee looked at the list of potential cuts as well as at the technology plan.

4.5 Board of Education Member E-mail Addresses*

Superintendent Phelan explained that one of the benefits of the District going to Office 365 is that in addition to allowing students in grades K-12 to have district supported and regulated email capability, we have the same capability for teachers and board members at no additional cost. The Board agreed to activate accounts for all board members.

5.0 Comments

5.1 Good News

Ms. d'Albertis expressed her appreciation for the Artist in Action Day at the middle school. She also expressed her gratitude to the BLPT who are a great and highly effective engine for making things happen in our schools.

5.2 Old Business

Mrs. Lyons stated that she intends on running for re-election to the Board of Education.

5.3 Public Comment

A senior high school student spoke on the start time issue and how it affects sports and homework. The Board reported that the District is looking for minimal disruption to athletics and early morning electives. The student reported that many students use the library during study hall but get asked to leave when a class is using the library. She asked for the possibility of having classes use the lab instead so students can continue to use the library to get away from the distractions in study hall.

5.4 Other

President Fleischhauer received an email from a concerned resident about speeding during school hours on Knollwood Road. The District has already started the ball rolling on communications to parents about the speed limit around the school through various means of communication. The Mayor, also included in the email, has assured the District that the Village will investigate the matter.
