4.0 Reports and Discussion

4.1 Board Committee Reports (Personnel, Audit)*

Personnel Committee

Ms. Rosenthal reported that the Personnel Committee discussed the upcoming Rhinebeck Administrators Association (RAA) negotiations and revisions to the superintendent evaluation form.

Audit Committee

Mrs. Schulkind reported that the Audit Committee reviewed the proposal letter from the internal auditor (Vanacore) to test internal controls and procedures around payroll expenses and records management in June. The committee reviewed the external audit engagement letter from Toski.

5.0 Comments

5.1 Good News

Superintendent Phelan reported that the Rhinebeck Village Board has asked the District for a letter of support to obtain a grant from NYSERDA to establish a microgrid in Rhinebeck. The microgrid will provide backup power to the community and the District in the case of an emergency. The Board gave their support.

The Board appreciated the great work and talent that went into the high school play.

Mrs. Schulkind reported that the marble sorting demonstration by the high school Principles of Engineering class was terrific. Three groups of students presented marble sorting mechanisms in which they had to plan, program, and present.

5.2 Old Business

The Board briefly discussed the 3-8 Math Assessment opt-out count for Rhinebeck, which was 81 out of 494 students. Ms. Burns stated that the State Education Department (SED) has come up with a way to arrive at a score for teachers who do not receive a state growth score due to the opt-outs, calling it a "Backup SLO". Superintendent Phelan mentioned that this might impact grades 3, 6, 7, and 8 teachers, as numbers of test refusals in grades 4 and 5 were minimal.

Ms. Burns believed that the reaction from SED seemed like a convoluted effort to come up with data rather than creating a system that improves teaching. A short discussion followed regarding the reasons that SED is not letting schools "off the hook" from turning in data, even if it has limited meaning. Ms. Rosenthal said that one issue that complicates the matter is that legislation was passed years ago regarding the APPR, and SED must collect the data to comply with their obligations as a governmental agency.

The Board discussed revisions to the budget statement to be published in the budget newsletter going out to the community. The District is prohibited from advocating and/or giving their opinion on the budget. One Board member opined that the purpose of the document is to inform the community about the budget only, although not all trustees agreed with that opinion. After much discussion, the Board agreed to amend the budget statement, using revisions suggested by Mrs. Schulkind, if possible, before it goes to the printers. The Board would like to explore other venues to express their opinion about how the District is being impacted by decisions in Albany.
