Stakeholder Relations Committee Meeting

Family Town Hall

Discussion: Seventy-seven families participated in last week's superintendent-hosted virtual Town Hall and Albert received very positive feedback from those in attendance. Participants indicated that they were grateful for the sense of connection offered by this and other similar Town Hall events. Additionally, the format of pre-event question submission seemed to work well and provided a good framework for the meeting. Decision: The Committee agreed that Town Hall communications are a productive use of available technology and make it convenient for families to remain connected to District happenings from the comfort of their homes. We further agreed that it would be beneficial to host superintendent-led Town Halls on a regular basis, perhaps monthly or every six weeks. (Albert leads similar meetings on a weekly basis with District faculty and staff and has received an overwhelmingly-positive response.) The Committee requests the Board's input on the frequency of future virtual Town Halls.

Website Committee

Discussion: Steve provided an update on the progress of the two sub-committees designated to select a new web platform for the District. He indicated that all meetings to date had been productive and sensitive to the needs not only of the District, but of each individual school within the District. He is in the process of meeting with different companies to assess their offerings and compatibility with District needs.

Decision: The Board of Education brings a unique voice to this conversation as a bridge between the community and the District, and the Committee would like to receive feedback on the Board's desired changes to the current web platform, with specific attention to Board engagement with and inclusion in the new platform.

Brochure


Discussion: Steve provided an update that digital revisions are in progress.

RE: Nominations and Election for BOCES Board - 3 Open Seats

This year the terms of office of three members of the Dutchess County Board of Cooperative Educational Services Board will expire on June 30, 2021. Mr. Edward McCormick (Arlington), Mr. Robert Rubin (Wappingers) and Mr. Richard Keller-Coffey (Webutuck) have indicated that they will be candidates for nomination and re-election for another three years.

Nominations:

The Education Law does not limit the number of candidates a Board may nominate provided that:

- the nomination is by official Board resolution;
- the nominee resides in one of nine component districts (Arlington, Dover, Pawling, Pine Plains, Poughkeepsie, Red Hook, Rhinebeck, Wappingers or Webutuck);
- the nominee is not an employee of any component district in Dutchess County;
- March 23rd is the nomination deadline.

The BOCES District Clerk must reject a nominee if the person nominated is a resident in a component district that currently has a resident serving on the BOCES Board whose term will not expire at the end of the current school year. (Beacon, Hyde Park, Millbrook or Spackenkill)

Nominations must be received by the BOCES District Clerk on or before March 23, 2021. The BOCES District Clerk will notify component District Clerks of the names of all nominees after March 23rd. Nominees attending the BOCES Annual Meeting on April 1, 2021 at 5:15 p.m. will be introduced at that time.

Election:

The election, by law, must occur in either a regular or a special meeting of each component Board of Education convened on April 27, 2021, for the purpose of casting ballots. This April 27th date is the only date allowable for this election. Each component district may cast only one (1) vote for each vacant seat. The candidate receiving a plurality of the votes cast will be elected, provided, however, that no more than one candidate residing in a participating component district may be elected. The results will be issued through a press release immediately thereafter. Please schedule a meeting of your Board on April 27th
